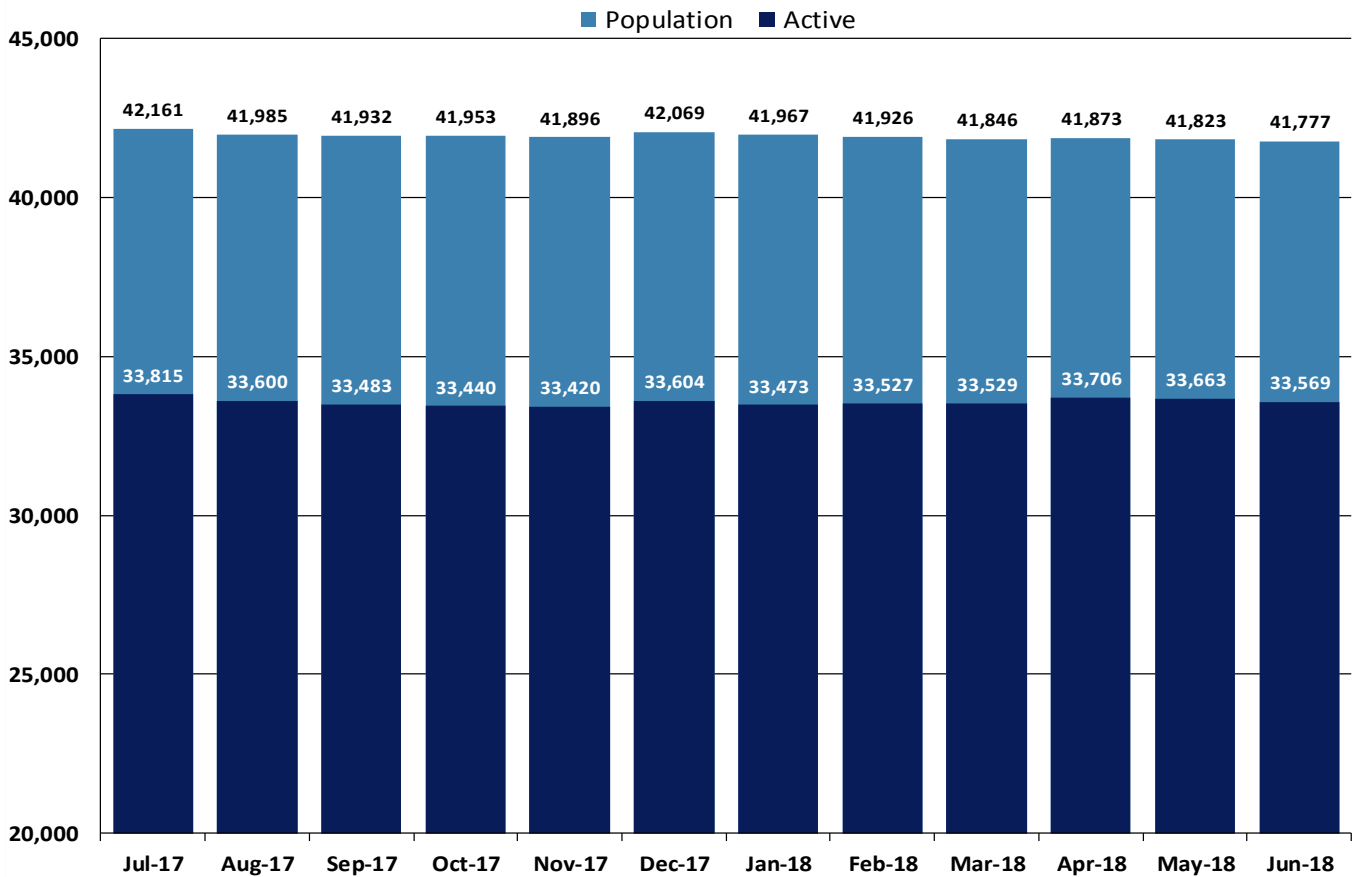

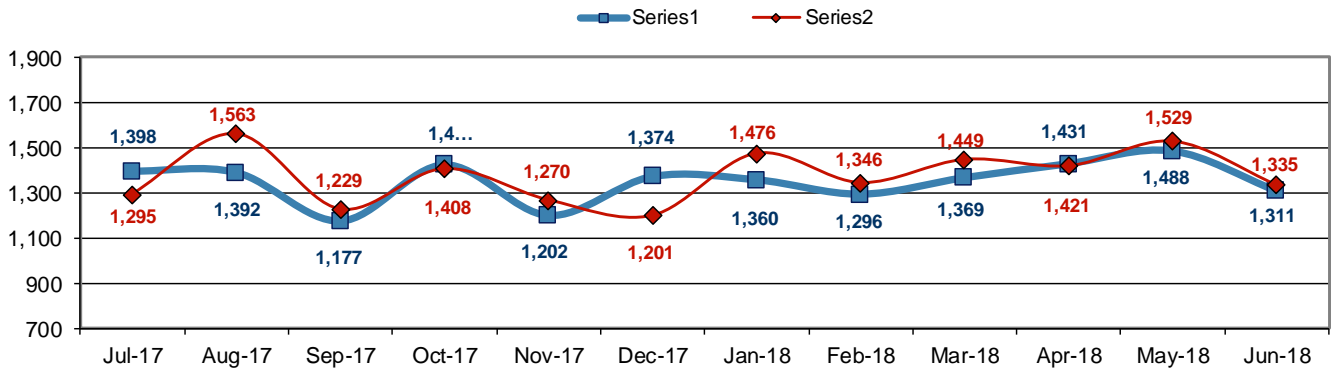
Population - Retrospective Year View



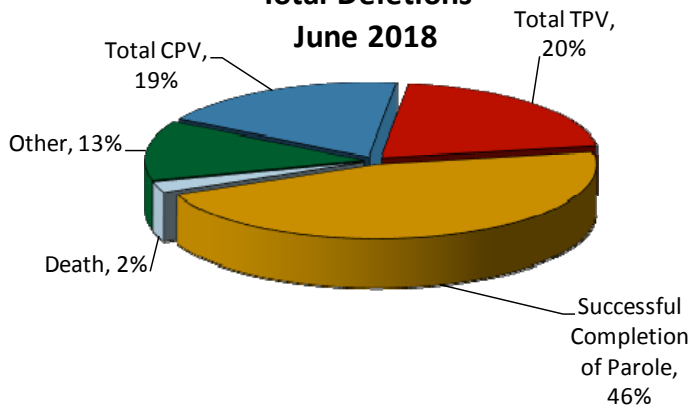

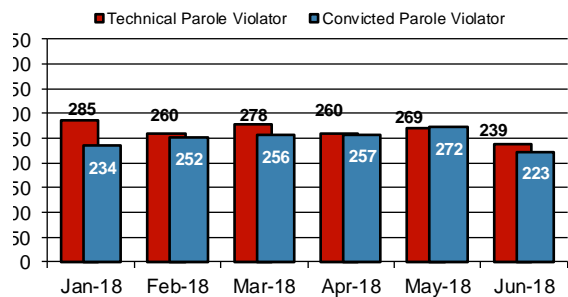
Population Additions & Deletions-Retrospective Year View

State Sentence Parole Revocations*

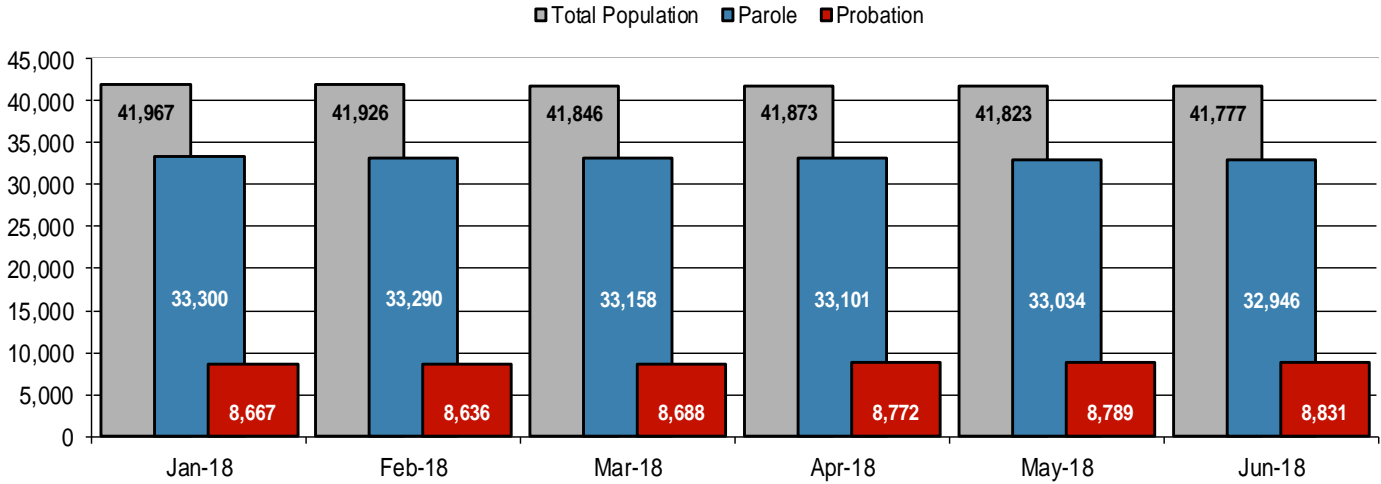

Supervised State Sentence Cases

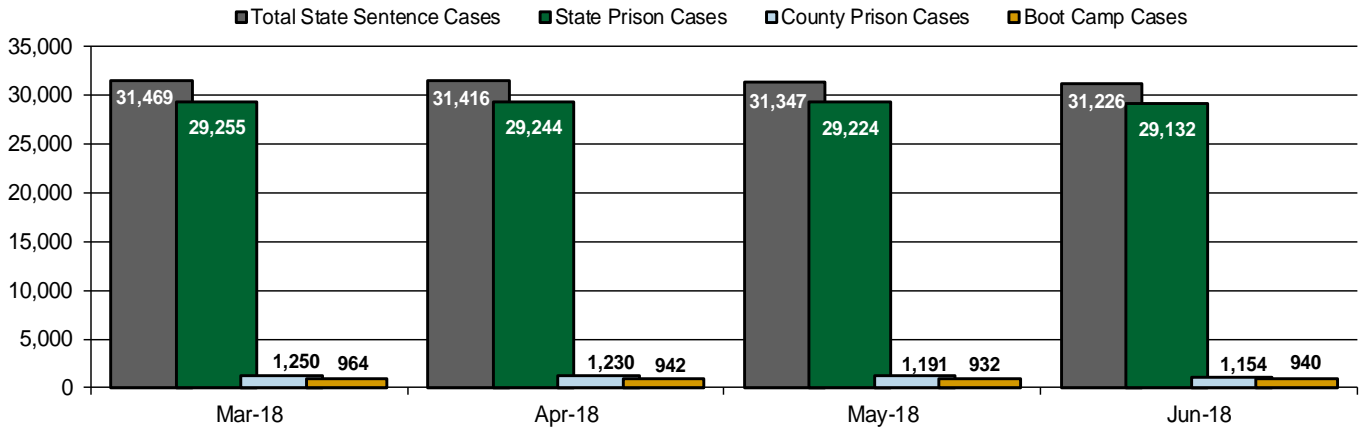

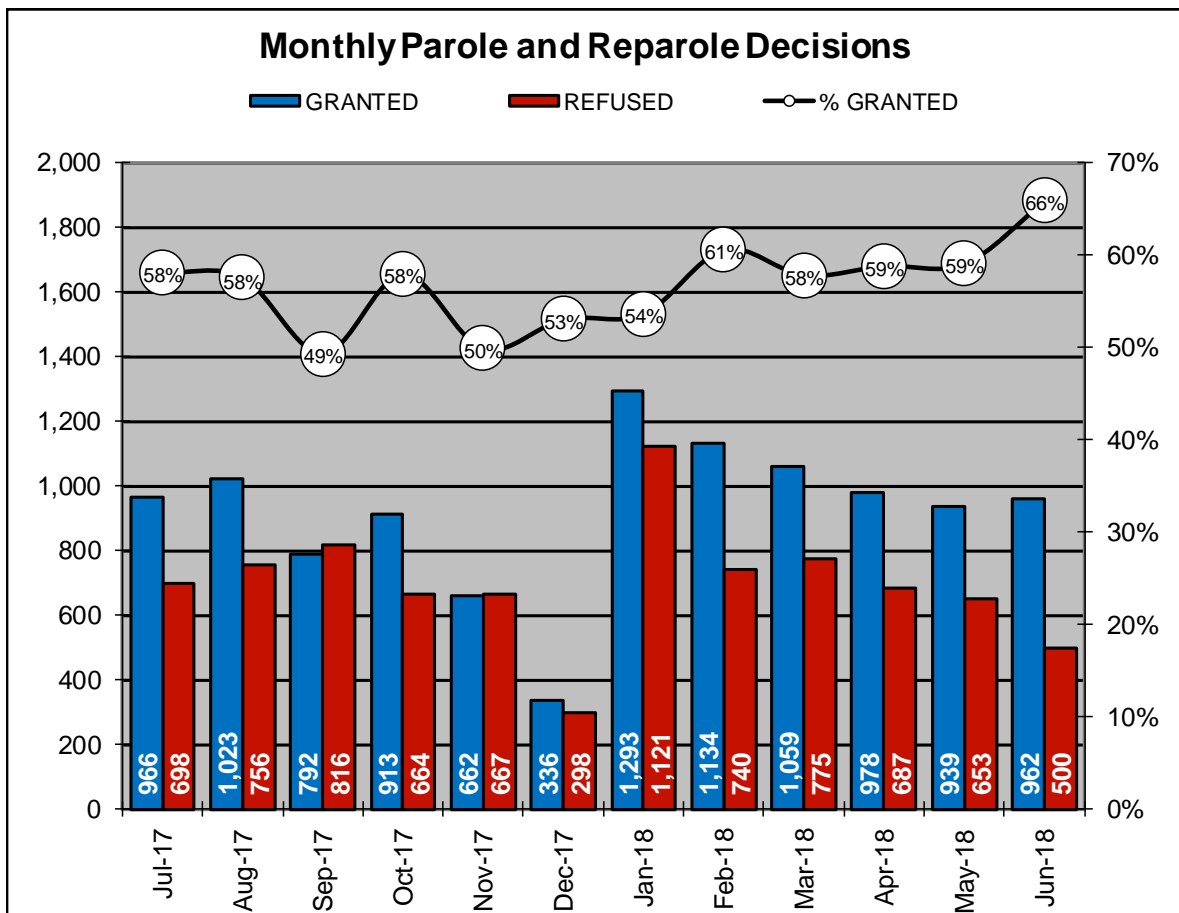

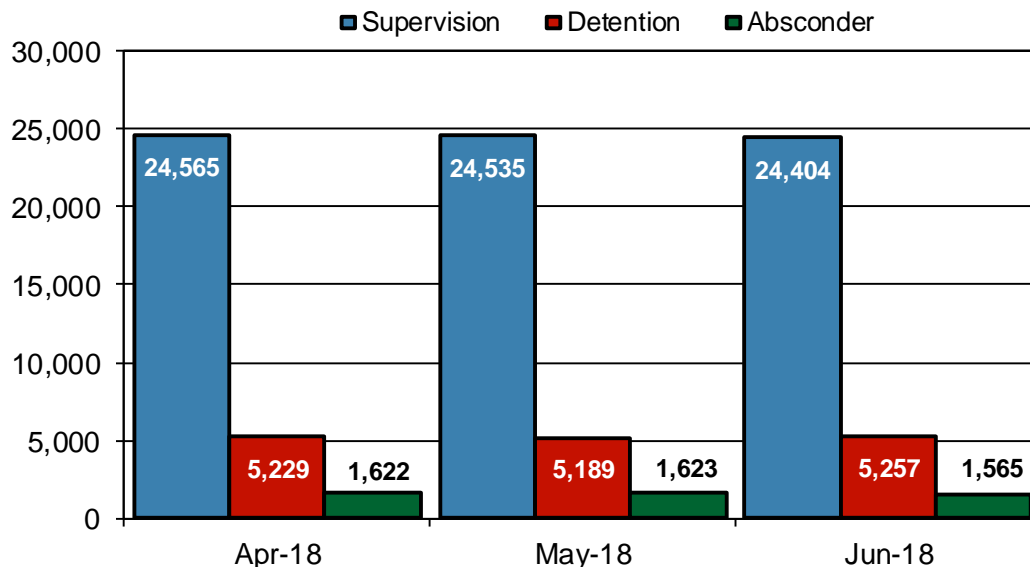

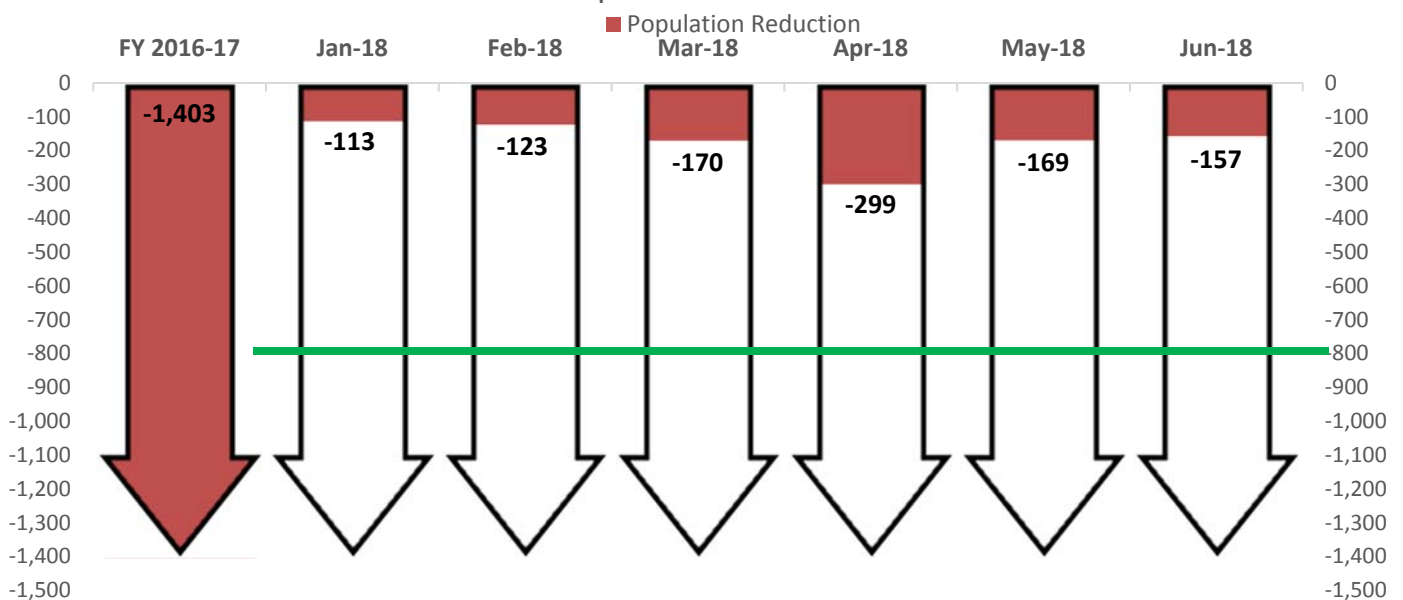
State Sentence Cases by Offender Status
