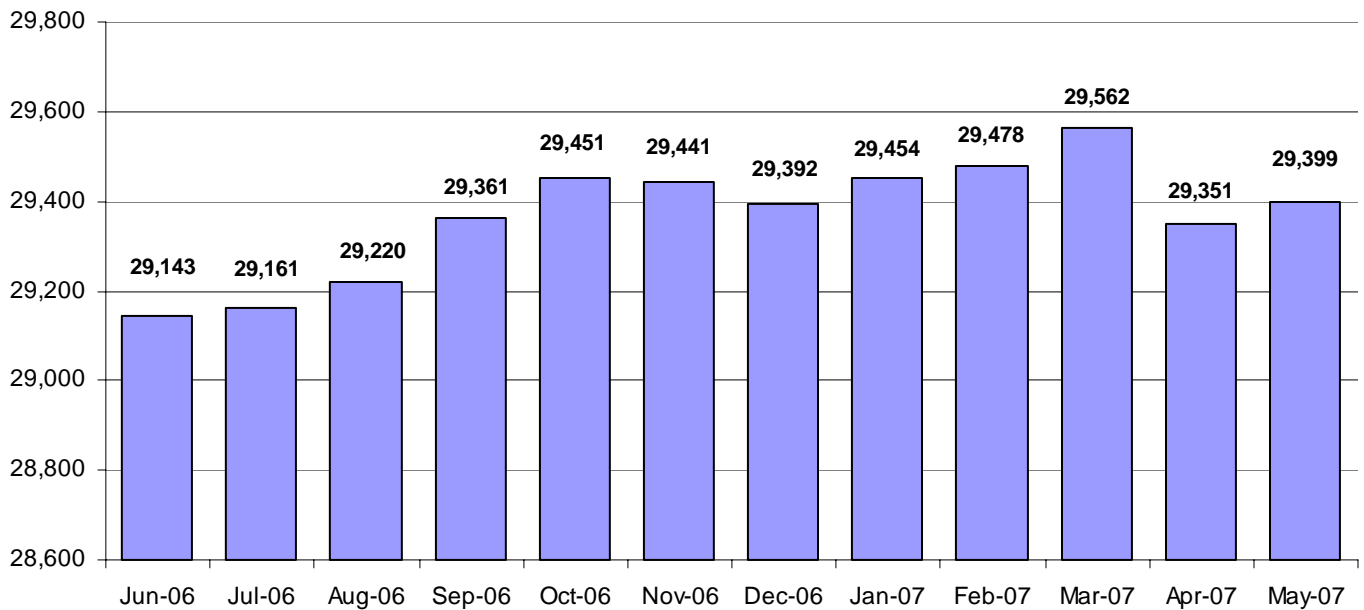

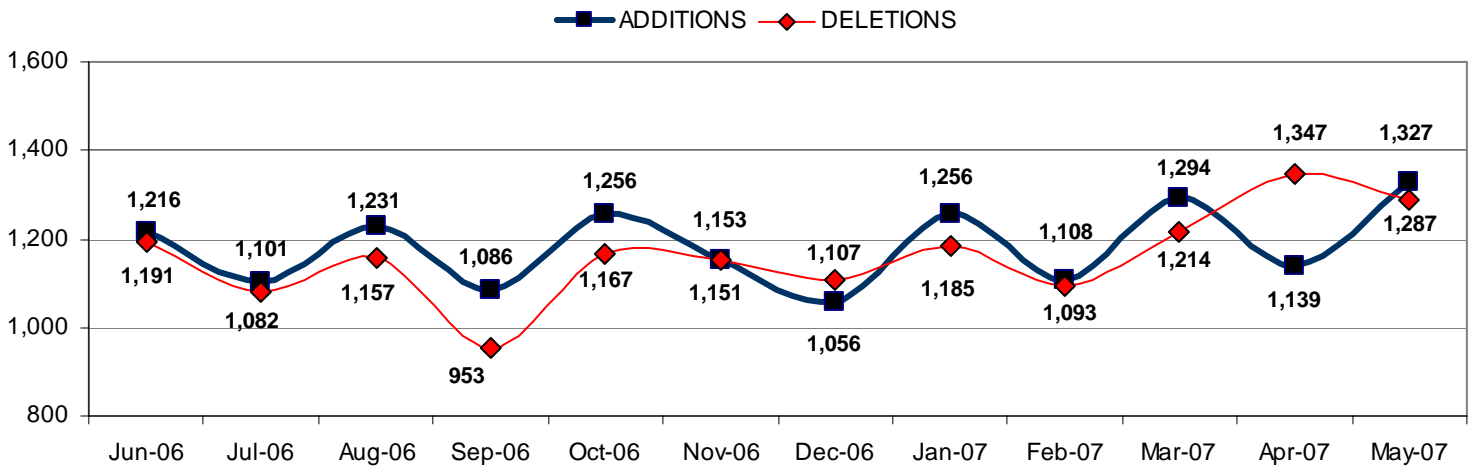
Population - Retrospective Year View



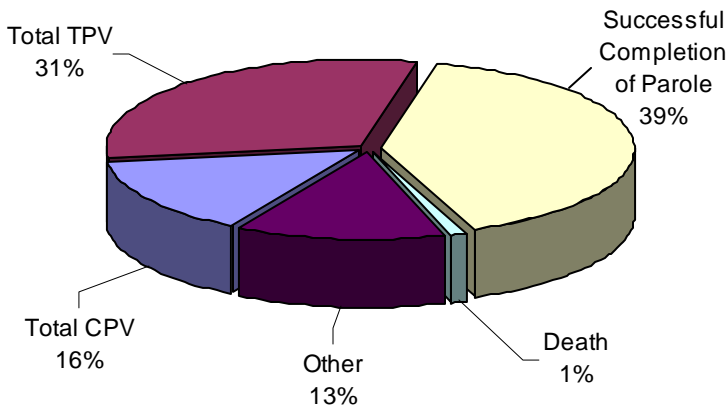

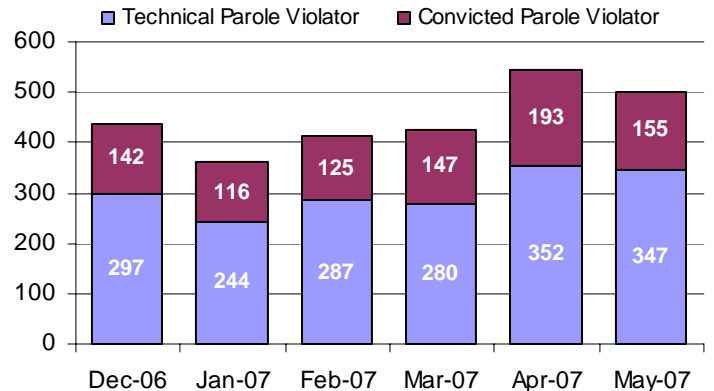
Population Additions & Deletions-Retrospective Year View

State Sentence Parole Revocations*



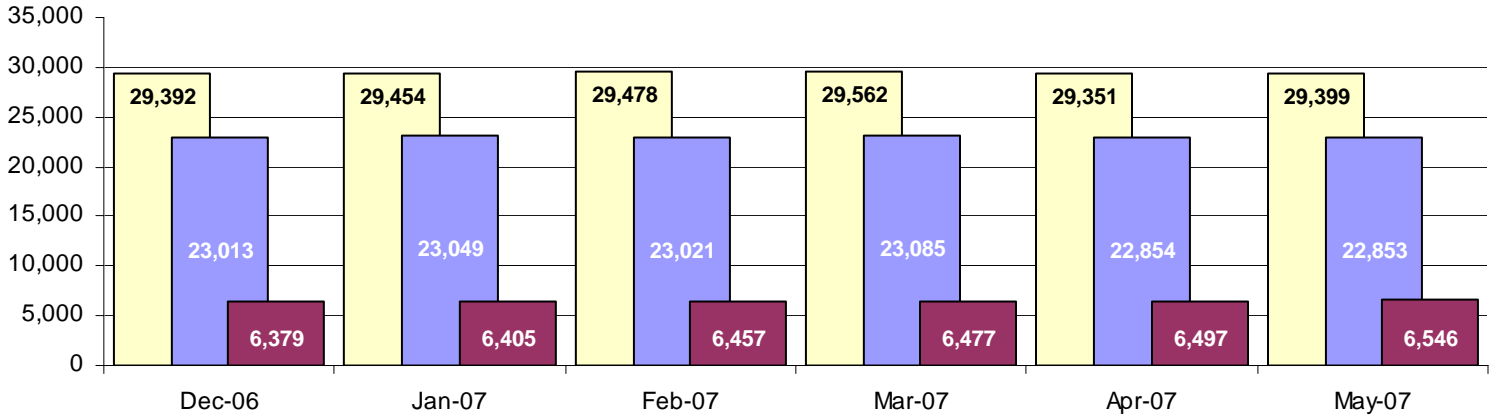

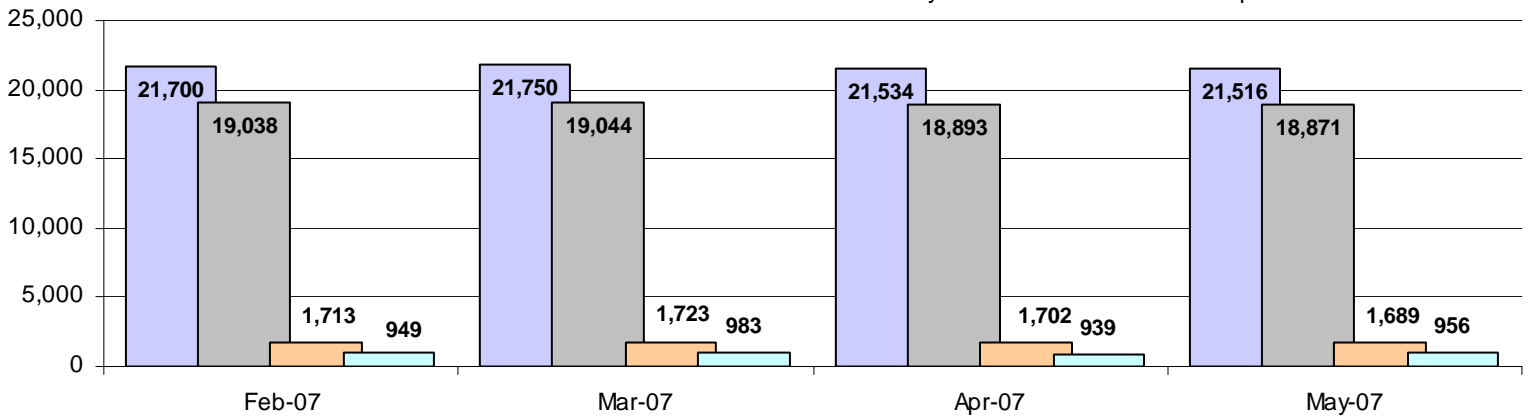

Number of Detainees and % of Population

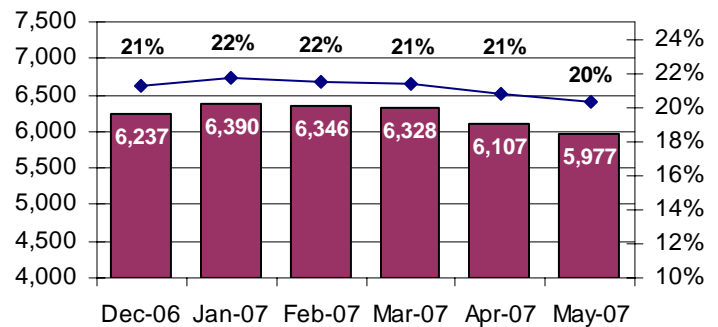
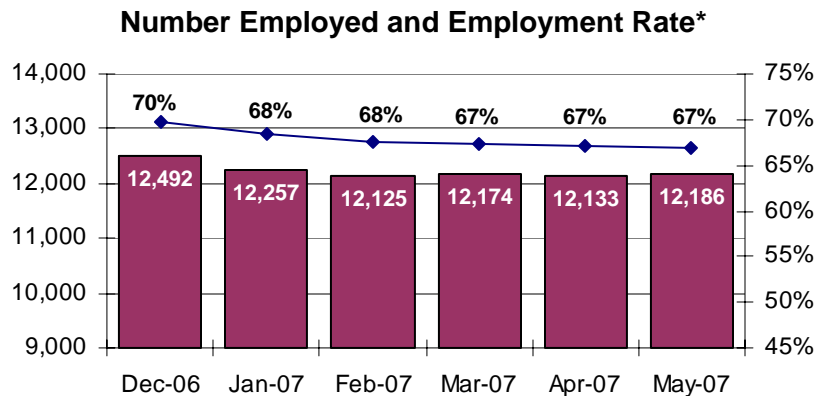

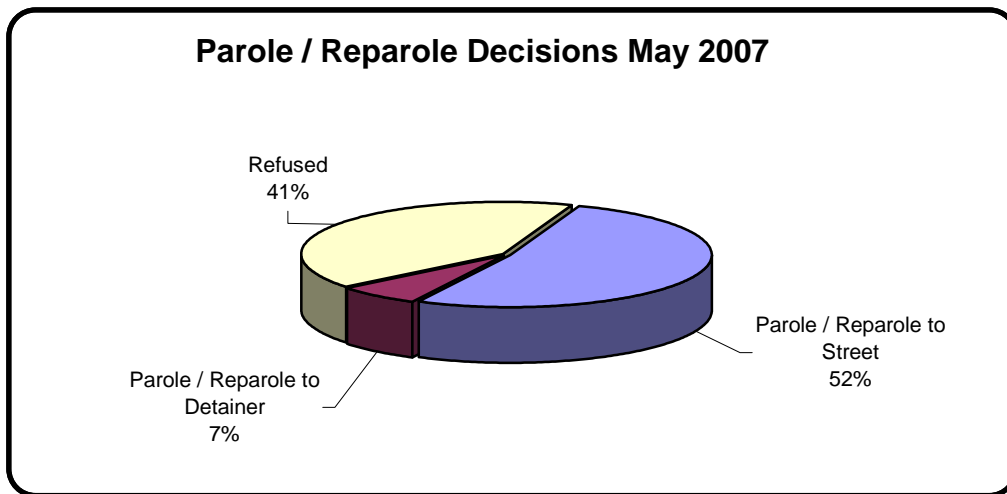

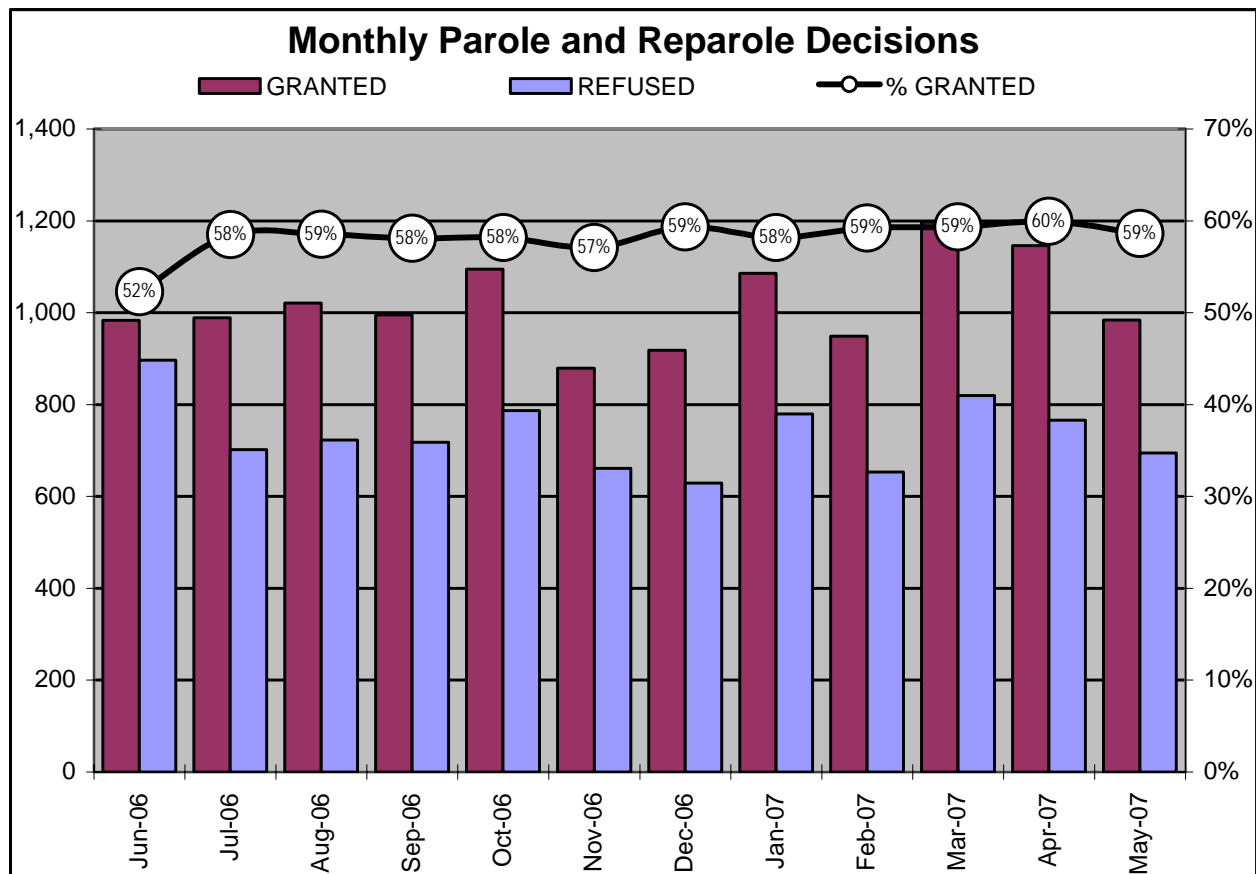

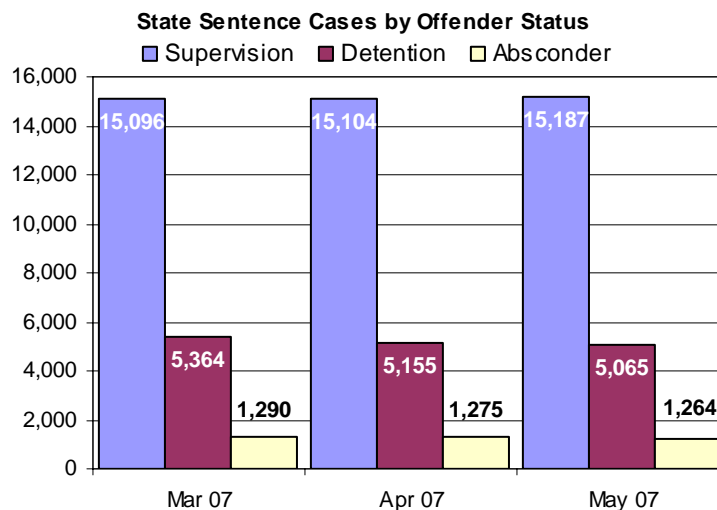

PBPP Population Breakdown By Place of Incarceration/Jurisdiction – May 2007

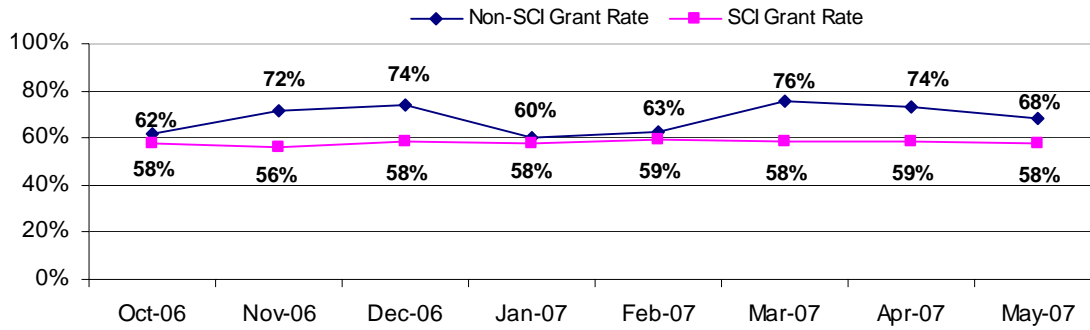

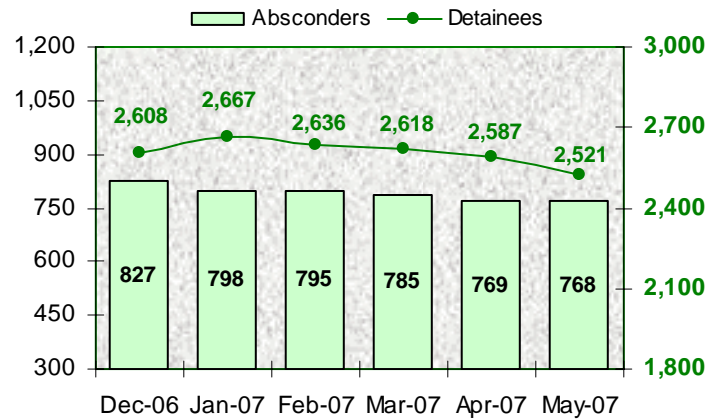

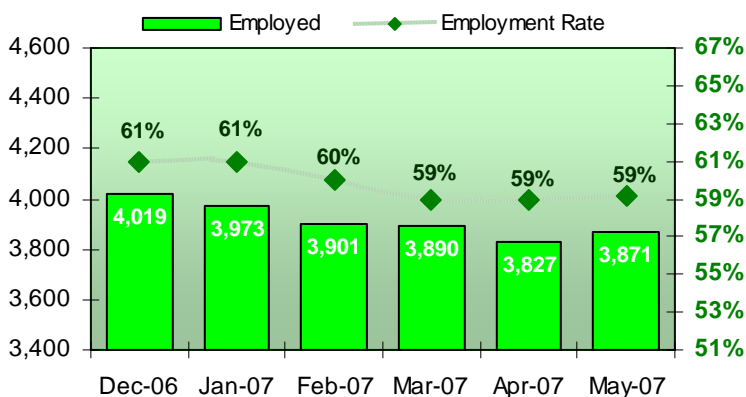
- The Eastern Region's previous six-month average number of state sentence additions is 281. May 2007 amount is 4% more than the previous six-month average.

Number of Absconders and Detainees



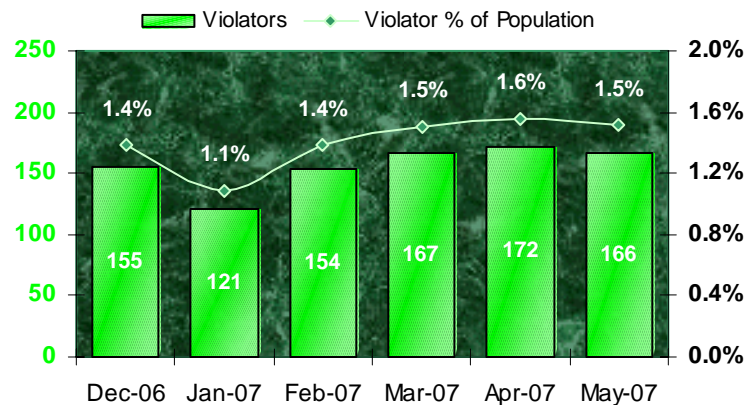

- The 166 Eastern Region state sentence parole violators in May 2007 consisted of 38 convicted parole violators (23%) and 128 technical parole violators (77%).

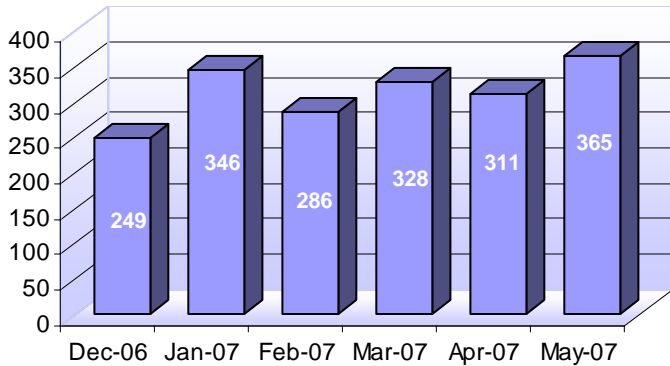

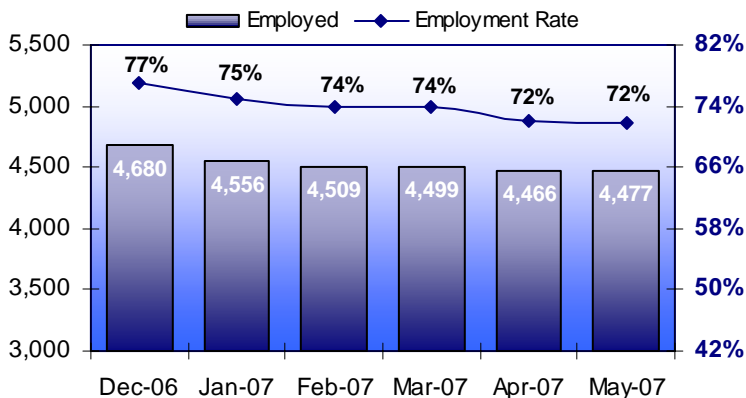

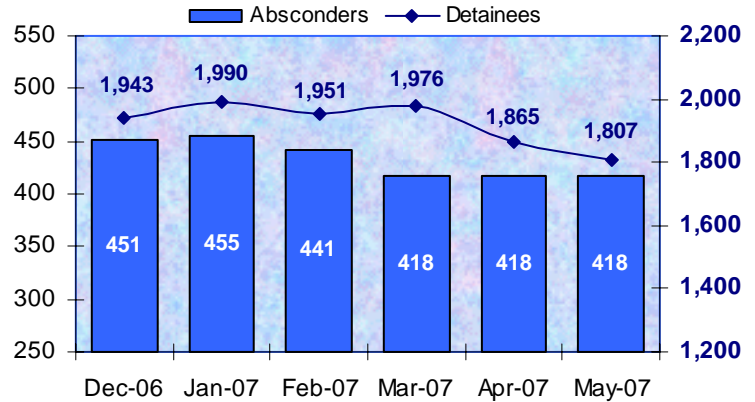
- The Central Region's previous six-month average number of state sentence additions is 296. May 2007 amount is 23% greater than the previous six-month average.

Number Employed and Employment Rate*



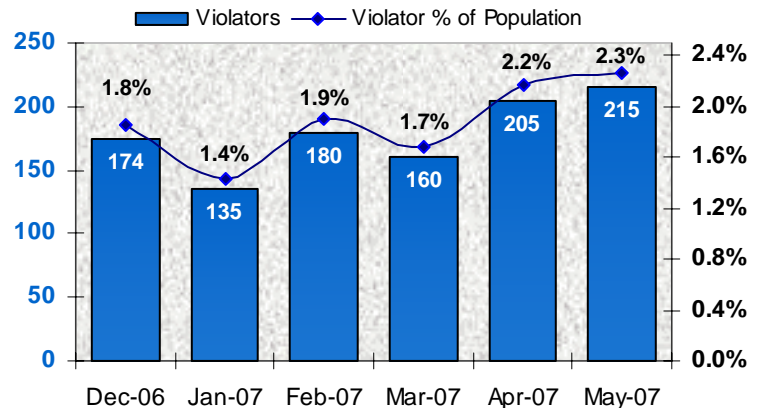
- The May 2007 employment rate was three percentage points less than the previous six-month average of 75%.

- The 215 Central Region state sentence parole violators in May 2007 consisted of 80 convicted parole violators (37%) and 135 technical parole violators (63%).

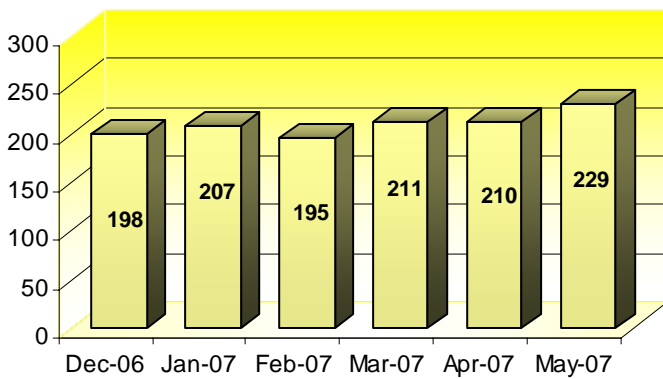

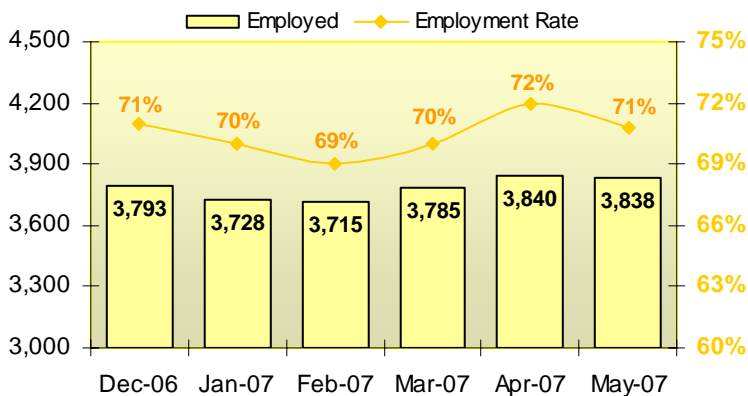

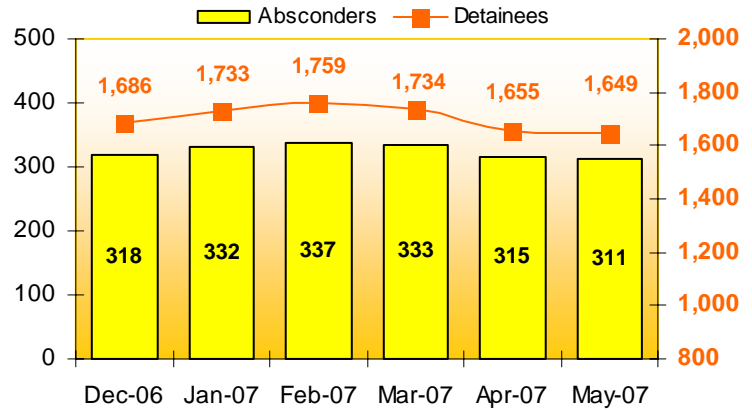
- The Western Region's previous six-month average number of state sentence additions is 209. May 2007 amount is 10% more than the previous six-month average.

Number Employed and Employment Rate*



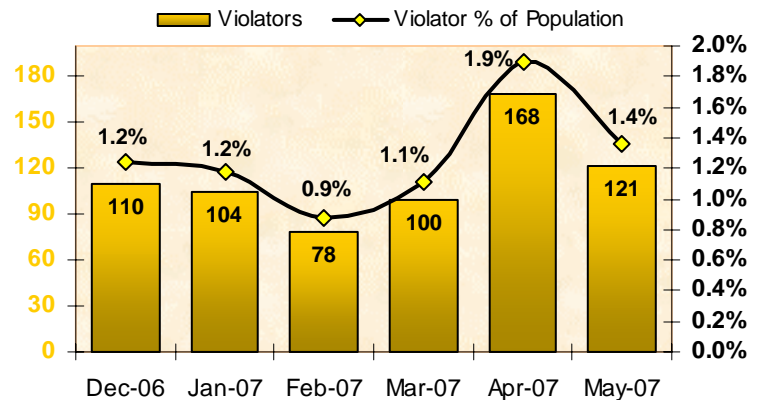
- The May 2007 employment rate was equal to the previous six-month average of 71%.
